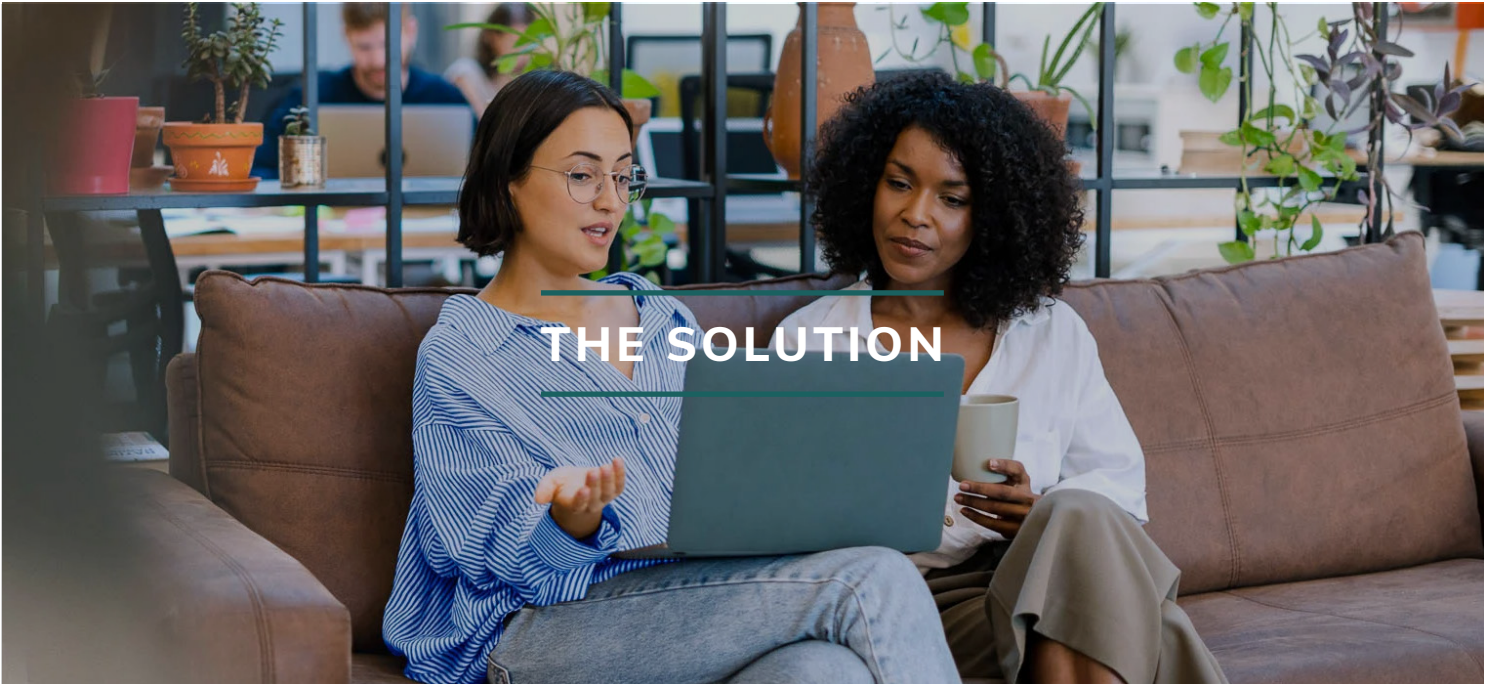

It is Europe's leading platform for sharing knowledge in the non-listed (unlisted) real estate industry. INREV professional standards enable consistency, allow peer-to-peer comparisons and promote market transparency. By automating INREV reporting, Vistra will **save at least one week per quarter**.
